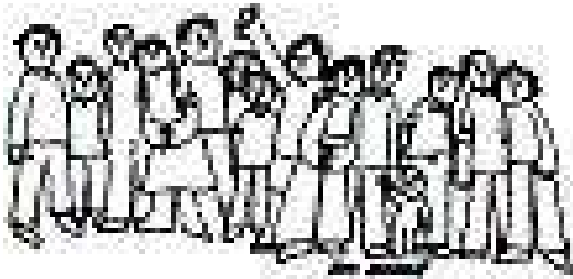

## **Plenary Speakers:**

- Neftali "Charles" Olmeda is Senior Pastor of the multi-ethnic, bi-lingual, 3rd Day Worship Center in Allentown, affiliated with the Assemblies of God. Rev. Olmeda has served as President of the Board of Directors of the Lehigh Conference of Churches and currently leads a planning committee focused on providing re-entry assistance for people returning from prison.
- Andrea James has worked within the criminal justice system for more than 25 years as a youth worker to a former criminal defense attorney. She dedicated her time and resources to providing zealous representation to families within her community of Roxbury, Mass. In 2009 she was disbarred as an attorney and sentenced to 24 months in federal prison. What she encountered in prison motivated her to establish Families for Justice as Healing, a criminal justice reform organization advocating for community wellness initiatives to replace the "War on Drugs" and incarceration.
